#### A dilemma for the future of a printed version of the News.

Help! We face a dilemma regarding the production of Stoneleigh and Ashow News.

Just before lockdown, Jean and David Vaughan reluctantly decided to step down from their invaluable role as co-ordinators of the distribution of the News. Huge thanks are due to them for their work over many years.

Several aspects of COVID-19 restrictions, and the fact that many of our distributors are over 70, meant that in recent months it has only been possible to produce an online version of the News. Regrettably this has meant that those residents who do not yet have internet access have missed out, as have those who do not check the village website and/or who prefer to have a hard copy for general reference.

Looking to the future, if we are to be able to offer a printed version, within current virus constraints and bearing in mind the financial implications, the main challenge facing us is making new arrangements for distribution. We need someone who is willing and able to take on the co-ordination role, ensuring that the bundles of copies are delivered to the team of around 17 distributors, each covering a different section of the Stoneleigh and Ashow and the surrounding areas.

We also need some replacement distributors. The deadline for submissions remains the 18<sup>th</sup> of the month and distribution takes place by the end of the month (except August and December).

#### **HS2 UPDATE**

This report has been prepared by Martin Smith, Chairman of the Stoneleigh Action Group against HS2, and Anthony Bianco, Parish Councillor, coordinated by Margaret Wallis

The HS2 project is progressing relentlessly, causing environmental destruction, disruption of communities and traffic chaos in its wake, with far worse to come.

The associated work on the Birmingham Road during July did not cause as many problems as originally anticipated, as a daytime one-way traffic light-controlled system was used, rather than a night full closure. This change was the result of the rapid, professional action taken by the Chair of the Parish Council with HS2 Ltd. Contractors Laing Murphy O'Rourke (LM) and Warwick County Council. However, a continuation of some aspects of this work might well affect our community for some time; residents may have noticed ongoing tree-felling, removal of 'chalets' on Stoneleigh Park as well as the everchanging traffic control measures.

The Parish Council, District and County Councillors have chaired or taken part in a number of Zoom meetings in the last 4 weeks in an attempt to find a sensible and productive way forward.

The key issue in all the recent meetings is the project to enable the opening and operation of the main compound near the A46 /Stoneleigh junction with target opening date from October 2020. The preferred entrance to the compound is 50m south of the A46 junction, on the Stoneleigh Road. This scenario was only confirmed on July 20<sup>th</sup>, despite this being a regular agenda item for discussion with HS2 Ltd. for at least the last four years.

The problem is that HS2 Ltd. have failed to legally and financially negotiate the approximate  $350 \times 25 \text{ m}$  'ransom strip' involved. HS2 Ltd., landowners and covenantees are now requested by the communities affected to make the settlement of this issue a priority.

Meetings in recent months have been pursuing a pause and a reconsideration of the alternative proposal announced in June (without public consultation) to make the B4115 one way for 5 years from the Thickthorn/Chesford Grange (A452) junction to Stoneleigh crossroads and back to the A46 Junction, to meet the compound entrance/exit needs described above.

The proposal is expensive, needs careful safety planning, involves disruption and major traffic, social and business inconvenience to the Parish Council area, including the Abbey who have joined the concerned group plus our neighbours in Kenilworth, Leamington and South Coventry. In short: a complete nightmare!

The problem is the subject of ongoing discussions with Jeremy Wright MP who is taking this up with HS2 Ltd. following work by the Parish Council and County Councillor Wallace Redford.

Recently, there has been noticeable (and less than legal) heavy traffic in the village. Thanks to the ever-vigilant Sue Malone, Sheila Woolf and the coordinator, Martin Smith, it has been possible to pin down regular culprits. The result has been speedy action by contractors LM and improved operational activity by the now main contractor on site Balfour Beatty VINCI (BBV). New, very clear signage is promised for the crossroads at both ends of village.

The A46 Junction project is now on target to start work in October. The Warwick County Council Project team are working with HS2 and Highways England, and have been very helpful to the Parish Council, with the next update in mid-September.

The Gas Main diversion being undertaken by Cadent. This is now underway and Crewe Lane will be closed until the 30<sup>th</sup> August. The Cadent project communication team and management have been very helpful in providing full notification at all times. They hope to complete the works on Crewe Lane on or ahead of time. Thanks are due to Cadent who have been far more helpful and easier to deal with than HS2 Ltd.

## **Stoneleigh Community Orchard Update**

At the start of summer and with the COVID-19 lockdown starting to ease, there arose the opportunity to develop our cider processing plant. In advance of a potentially large harvest, tilers were brought in to complete the processing facility. Quality racking was then introduced to create more space and to enable a safer working environment during pressing. The results of this piece of work were well worthwhile and preparation is currently ongoing in advance of the harvest to sterilise the processing area to minimise the possibility of the cider spoiling during fermentation.

It seems to be an increasingly common pattern that during August the summer heat is punctuated with occasions of high wind, which normally leads to a number of trees getting damaged. This year, one of our most productive "Morgan Sweet" cider apple trees, being heavy in fruit, became damaged in high winds. The current plan is for the damaged bough to remain in situ in the hope that the fruit will ripen, then following the harvest, work will be undertaken to address the damage to the tree.



In late July and in response to an explosion in Himalayan Balsam covering of the banks of the river Sowe, John Churchley and I endeavoured to reduce the area of this invasive plant. Unfortunately, our efforts proved unsuccessful given the magnitude and extent of the task and so we were forced to "beat a retreat" in the afternoon heat!

Himalayan Balsam is a native of Kashmir and Uttarakhand and was first introduced to the UK during the reign of Queen Victoria. Due to its aggressive seed dispersal, coupled with high nectar production which attracts pollinators such as bees, it out-competes native species. It is tall and possesses attractive pink coloured flowers that line the river bank. River bank erosion can occur following the dying back of this plant leaving river banks exposed to flooding. Any suggestions about how to control it would be welcome.



Finally, in late August and early September the harvest is likely to commence. If folk want to get fit following the inactivity of the COVID-19 lockdown there is in no healthier way of spending a day than in the field picking fruit. Volunteer pickers would be most welcome!

Orchard Friends' subscriptions and yearly renewals for 2020 cost £10 and can be made to Pete Freeman as Chairman or to Richard Hancox as Treasurer. Cheques should be made payable to Stoneleigh Village Community Orchard, however why not become a long term friend and set up a direct debit?

#### **Meetings**

The July meeting covered subjects including parking on the B4115, HS2 and flooding in Ashow and Stoneleigh. Minutes of the meeting are available on the Parish Council website.

The consultation regarding the closure of the Birmingham Road has now closed and the votes are with Warwickshire Association of Local Councils who will analyse the results on behalf of the Parish Council. We received a significant number of replies and are hoping to have the results by the time the Parish Council meets in September.

There were some recent incidents of flooding in different areas of the parish. The Parish Council is working closely with County Councillor Wallace Redford and officers at Warwickshire County Council to investigate the causes of the flooding and see what action can be taken to alleviate it. Residents can help by keeping an eye on the drains and gullies near their homes and reporting any issues to the Parish Council, ideally with photographic evidence, so we can give a heads-up of any developing problems to Warwickshire County Council. If you think that the drains or gullies near you are becoming silted up, please email the Clerk so we can pass on that information.

One of the many worrying aspects of the COVID-19 pandemic is the rising number of scams that are linked to the virus, as criminals seek to take advantage of people's concerns and possible confusion. Criminals are using emails, text messages, social media posts, online advertisements and phone calls to defraud their unsuspecting victims in many different ways including fake home testing, fake contacts from NHS Test & Trace staff, false adverts for priority food delivery slots, fake cures for COVID-19 and so on.

Make sure that you get your up-to-date advice about coronavirus from a trusted website, such as <a href="www.warwickshire.gov.uk">www.gov.uk/guidance</a>. There is a lot of information online about scams and what to look out for. Remember, if in doubt, check before you give out any personal information or pay money for goods or services.

Information about COVID-19 is changing quickly, and we are keeping our Facebook page up to date with the latest developments. Don't forget to check out the Parish Council website which is regularly updated with local information such as road and traffic issues, HS2 updates and local consultations. #### **GOOD NEWS!**



#### **Celia King**

Everybody within the two villages, and far beyond, has been deeply saddened by the sudden and untimely death of Celia, who passed away on the 12<sup>th</sup> August 2020 in her 71<sup>st</sup> year.

A Stoneleigh girl through and through, she moved into a newly-built house in Hall Close with her parents and her sister Jean at a very early age, and had a wonderful village childhood. She attended Stoneleigh School before moving on at the age of 11 to Kenilworth School with her close friend Jackie (Sibley) before starting her working life, which was spent in the Civil Service, firstly in Leamington before they moved their offices to Coventry.

A lovely lady with a gloriously cheerful smile, she had a great sense of humour which made for very good company. Her selflessness manifested itself in her concern for others, and whenever you enquired after her health and well-being it was only a matter of seconds before she had managed to turn the conversation into a genuine enquiry about you and your family.

Celia was a very Christian lady in her concern for others and in her own religious beliefs. She worked tirelessly for Stoneleigh Church, which was a place that she loved. She has served as a sacristan and verger and was always on hand to do anything that was needed, helping in so many ways. If you ever tried to thank her though, you couldn't – her typical answer was always that other people did far more than she did.

In recent years she underwent very invasive treatment for myeloma which she bore with great strength and dignity. Although so often in great discomfort, you couldn't keep her down and as soon as she was able she was back doing whatever she could to help, and always with that lovely smile.

To have known her and to have counted her as a friend has been a huge privilege, and I know I speak on behalf of so many.

### **Funeral of Celia King**

Stoneleigh Church has confirmed that Celia King's funeral will take place at 11am on Tuesday September 8<sup>th</sup>, followed by interment in the graveyard at noon.

Only 30 people are allowed **inside** the church and the family are arranging this because of the current need to track and trace. There will be outside loudspeakers relaying the service to those who wish to attend in the churchyard.
